## Exhibitor Table Description

Dealer tables are ~6x3 feet. Dealer space is sold by whole tables and artist space is sold by half tables. We have 8 artist spaces and 16 dealer spaces available. Tables will be provided by Zenkaikon. Electricity and outlets are available for use with an additional fee/contract with the Scanticon itself. The Dealers Room hours will be 10AM-9PM. Setup for the tables will be from 8AM-10AM.

Tables are not guaranteed until we receive the full payment. Requests are considered on a first come, first served basis. Postmarks may be used to determine order.

## **Exhibitor Badges**

Exhibitors will be provided with 2 badges with their company name and are valid for admission into any event at the convention.

## **Security**

Zenkaikon and the Scanticon will provide as much security as possible. However, the vendor alone will be fully responsible for his/her own properties at all times and should insure all his/her properties against damage, loss, or other events. Zenkaikon and the Scanticon will provide the vendors' area continuous security during the hours that it is closed, and will have security staff monitor the area on a regular basis during open hours.

## **Anti-Piracy Policy**

Zenkaikon has an anti-piracy policy for dealers who participate in it.

We support efforts to reduce anime or sci fi piracy that is detrimental to the industry such as bootleg tapes. We do not want to argue over the exact lineage of items that might be illegal depending on the import method.

Violation of this policy will result in a warning. If the items in question are not immediately removed from the dealer room, the dealer will be expelled from the convention and asked not to return to future events.

The following are items that are **NOT to be sold** at Zenkaikon

- Burned copies of CD's, or Taiwanese knockoff Cd's (SM)
- Bootleg videotapes (includes the obvious cheap bootlegs recorded on blank video tape with printed labels, pirated copies of titles that have been released commercially in the United States)
- Any posters, idol cards, etc which read "Kodak", "Fuji", etc on the back
- Unlicensed reproductions of any products actually released by an American company.

## **Food Sales Policy**

## **Adult Materials and Weapons Information**

Dealers **MUST** comply with all appropriate laws. Any adult materials are to be displayed non-offensively and in a tasteful manner. Because we will have a good proportion of convention attendees that are minors, they need to be taken into consideration when designing your table layout. Weapons must be displayed in a safe manner to prevent accidents. At the request of the Zenkaikon staff heads, displays may need to be changed or removed or the dealer may face removal from the Dealers room.

All vendors accept full responsibility for the collection and payment of any local, state, and/or federal taxes. All vendors will receive the proper forms from the Pennsylvania State Sales Office prior to the convention and will be responsible for returning them accordingly.
